

## Overview of 2010 Proposed Bylaw Changes

#	Article Reference	Proposed Reason for the addition, deletion, or change
1	Article 3 (a) 2 & 3 delete	Redundant; there is no BCBOA certification and not a concern of the BCBOA if member of more than 1 chapter
2	Article 3 (b) 1 delete	Redundant; submitting fee and application to PIAA is not a concern of the BCBOA
3	Article 3 (b) 3 add:	Pay initial dues within 30 days of affiliation with the BCBOA to encourage membership
4	Article 3 (c) delete	Reference to no longer officiating recreation basketball; missed in the 2009 removal of commissioner position
5	Article 3 (d) add	Inactive officials may not officiate PIAA games; remove Berks County basketball games
6	Article 3 (f) 1	define <i>Non-working</i> and draw the parallel with Inactive and clarify that Executive Committee determines position
7	Article 3 (f) 4	Defines period of 5 weeks to create more precision of determining the period in question
8	Article 3 (f) 5	Defines that the Executive Committee shall determine placement on lists after 2 years of inactive, injury etc.
9	Article 3 (f) 7 remove & Change	Change 60 to 15 days to create timely decisions
10	Article 5 (b) 1 delete	...with the exception of the Judicial Committee
11	Article 5 (b) 1 insert	Insert comparison of the previous year's budget with actual expenditures for the fiscal year
12	Article 5 (b)(2)	VP shall serve as the chairman of the Fact Finding Committee.
13	Article 5 (b) 3	Under Secretary-Treasurer change duties to make timely deposits into BCBOA accounts
14	Article 5 (b) 3	Add ST duty of notifying the PIAA of all meeting including the Interpretation date as this is current practice
15	Article 6 (b) insert after 1 <sup>st</sup> sentence	The Executive Committee shall function as the Fact Finding Committee but shall be chaired by the V.P.
16	Article 6 (c) remove	Delete the end of sentence regarding the Executive Committee not having jurisdiction over Judicial Committee
17	Article 6 (c) add sentence	The Auditing and Finance Committee shall be responsible to prepare the audit of the previous fiscal year and compare those results to the BCBOA budget for that period. These results shall be forwarded to the President and the Executive Committee by September 1.
18	Article 6 (d) delete	Rewriting of discipline process to delete the Judicial Committee
19	Article 8 (e) add	Election ballots to be handed in within 10 minutes of the start of the last meeting. Conforms to present practice.
20	Article 9 (b) insert	Clarifies PIAA meeting requirements for BCBOA members.
21	Article 9 (d) delete	Delete meeting credit of one (1) recreation game or one (1) college game. We are a PIAA chapter.
22	Article 10	Delete this section of missed assignments. This is the responsibility of the BCIAA to address and enforce.
23	Article 11 (a) 3 delete	Interpreter duties relative to Commissioner position were missed in 2009 deletion of the Commissioner
24	Article 11 (a) 5 delete	Remove Interpreter duty to inform PIAA of Interpretation date as this is functionally the ST's responsibility
25	Article 11 (a) 7 delete	Redundant statement relative to the Interpreter
26	Article 11(c) (2)	Change Interpreter duties; shall not be permitted to coach PIAA basketball games
27	Article 12(a)(2)	Change Judicial Committee to Fact Finding Committee
28	Article 12(b)( 5)	Add duty to be member in good standing to file required PIAA disqualification form when in order
29	Article 13	Redo entirely to create new Fact Finding Committee and new process for addressing member's conduct
30	Policy—Dues Structure—	Add: "Revised" date of Oct 2009 to track previous revisions of this document
31	Policy Addenda Assigners	Delete Assigners information from Policy Addenda and just keep on website
